Guidelines/SOP for the students and Course Coordinators

All the students of 1st Semester (2021 Batch) are hereby informed that the authorities at NIPER, S.A.S. Nagar has decided to conduct End-term Examination online for 1ST Semester (2021 Batch) w.e.f. 24th January, 2022 to 07th February, 2022, as per the following guidelines:-

- 1) An undertaking shall be taken from the students that their internet, computer, mobile, What's App, and mobile scanner facilities are functioning properly.
- 2) Student will give another undertaking stating: "he/she shall not use any unfair means, failing which suitable disciplinary action under NIPER rules and regulations shall be initiated."
- 3) Each student must have a web camera installed on the laptop. Otherwise, each student must have a cell phone camera that will be used during the examination.
- 4) Each student willing-in with the course coordinator through a Webex group specifically created for the examination of individual course(s).
- 5) During the entire duration of examination, student shall be on the web camera/phone camera and visible to the course coordinator via the Webex group on video call.
- 6) Students will be provided encrypted question papers through email/what's App, one hour prior to the commencement of the examination.
- 7) All the students will acknowledge the receipt of question papers within 10 minutes.
- 8) The students will be provided password of the question papers 5 minutes prior to the start of examination.
- 9) The students will send a scanned copy of their answer sheets within 10 minutes of finishing the examination.
- 10) The entire exercise will be conducted under the supervision of course coordinator connected to student via Webex Video call.
- 11) After receipt of the answer sheet, the course coordinator will initiate the evaluation process and provide the marks and answer sheets to examination branch.
